

## Nerf War Waiver

This form must be read and completed prior to participating in this event, hosted by Manchester Sportsman Club.

I consent to allowing my minor child to participate in this event at the Manchester Sportsman Club. By signing this document, I agree that the below information is correct. I consent to, and understand, all the following conditions, and hereby and forever discharge from any claims and liabilities what so ever, without limitation, that I may have against Manchester Sportsman Club, the owners of the property on which the events are held, the membership, board of directors, and any other players or their relatives, who might injure me or my child, however arising. I make this release freely on behalf of my heirs, my executors, administrators and myself. I consent and fully understand:

- That the events are physically and mentally intense and may require extreme exertion to play.
- The possibility of injury to myself and others exists.
- That indoor or outdoor activities carry the danger of trips, slips, falling, and other common physical injuries or hazards.
- Participants are both physically and mentally prepared to participate in the chosen event.
- That eye protection is to be worn at all times within the gaming arena.
- I understand that failing to comply with any and all rules, stated verbally as well as written, will result in ejection from the chosen activity and no refunds will be offered.
- All participants and spectators shall follow the instructions given by Manchester Sportsman Club volunteers, attendants, and hosts.
- No climbing on any of the structures or buildings within the gaming arena.
- No consumption of any alcohol prior to or during the session or activity.
- I fully understand all the terms and conditions, both in documentation and in all verbal agreements, and give consent for my child to take part in this activity.
- I also give permission for Manchester Sportsman Club to use images of myself or my child taken during the event for advertising or promotional purposes.

By signing this Waiver, I assume any and all risk, and take full responsibility and waive any claims of personal injury, death or damage to personal property associated with this event at Manchester Sportsman Club.

I understand and confirm that by signing this WAIVER AND RELEASE I have given up considerable future legal rights against the Manchester Sportsman Club. I have signed this Agreement freely, voluntarily, under no duress.
